Refinance Escrow Charge Residential Loan	\$550. Fee includes courier, overnight delivery, e-document charges, and bank wire fees.
Reverse Mortgage Refi	\$600. Fee includes courier, overnight delivery, e-document charges, and bank wire fees.
Concurrent Junior Loan Escrow Charge Residential Loan	\$200 minimum. Negotiable based on the complexity and work involved.
New Construction Purchase Escrow Charge/ Construction Refinance	Seller escrow fee based on sales price. Buyer escrow fee based on loan amount, if the loan amount exceeds the sales price.
Manufactured Home Processing Fee	Basic escrow charge plus \$200 (does not include MHODS transfer fees)

Lender-Owned Property (REO) Sale/HUD Sale	\$100
Holdback Charge	\$200
Small Estate/Probate	\$100
Lien Release Tracking Fee	\$200 for the first lien and \$50 for each additional lien per sale or refinance.
Reconveyance Fee	\$250
Short Sale Transaction	\$200 for the buyer and the seller
Private Financing/Escrow Preparation of Note and Trust Deed	\$100

Oregon CAT Tax Fee Assessed.

Escrow fees are negotiable depending on the complexity of the transaction and the liability involved. Minimum escrow fee is \$180. Fee includes courier, overnight delivery, e-document charges, and bank wire fees.
